It is compiled alphabetically from four Accounts of Seamen's Wages,—one from September 12, 1776, to August 15, 1777; one from August 15 to October 15, 1777; one from October 15 to November 15, 1777; one from November 15 to December 31, 1777—and from a List of Officers and Men, without date, which is manifestly prior to the dates of the pay accounts. The names in the list, where they are in addition to those in the pay accounts, are indicated by the mark +. The letter B., in the margin, indicates those who received bounty, the information being derived from two accounts of "Bounties paid by the Ship Defence," amounting, in the aggregate, to £630. The time of service is not given in all cases, in the pay accounts, and in a number of instances the rank is omitted. As far as possible dates of promotion are given.
