The Constables Order'd to Return List of Taxables Ordered that the Sherriffs do procure from the severall Constables within their Respective Bayliwicks, the List of Taxables by them to be Return'd vnto his Ex^{ncy} the Govern^r & Councill by the 1st day of July next, wherein they are to be very exact & to follow the Directions of the Law in that Case, and th^t they further take care (where they find any supernumerary Tythables, which by former Ord^{rs} from this Board they were directed diligently to looke after) that they produce a List thereof before the Justices of the County Court to be held in June next & make Oath to the same in Ord^r that due Credit may be given to the Countrey, the Counties & parishes where such supernumerary Tythables live; which s^d Lists so proved are afterwards to be Returned vnto his Ex^{ncy} & c^a at the time & place before directed; And further Ordered that the Sherriffs do by the s^d time Return an Acco^t of their Collection of the severall Sumes of Tobacco by Act of Assembly due from the severall Publick Officers within this Province, the which by a former Ord^r from this Board they were Ordered to Collect & Receive.
