Sir.

The fourth of March John Chalmers produced a Number of Recruits to Col<sup>o</sup> James Brice Lieuten<sup>t</sup> of this County, to be passed, Part of those he, about that Time, brought over from Dorchester where; we believe, he had inlisted them. The Proceeding was not altogether so regular as we wished it, but, thinking it not worth while to send them back for a mere Formality, we advised Col<sup>o</sup> Brice to pass them, if, on examination he thought them Effective. He did so their Names are Joseph  
166 Birch, John Bandy, Ruben Moore, William Cantwell, William Beaver, Thomas Bucklar, Peter Cahoon and William Gould, in all eight, of which we think it right to give you this Information, to prevent your County being charged with an over Proportion.
