Whereas his Ma^{ty} having obtaind Judgm^t for severall Sumes of Money upon Acco^t of fforfeited Navigacōn Bonds, for which his Ex^{ncy} has given his promise that no Executions shall issue thereon untill his Ma^s pleasure shall be further known; And it being Represented that some p^rsons (since Judgm^t passed ag^t them) have gone about or at least do Endeavor to Convey away or dispose of their Estates with intent to defraud his Ma^{ty} of such Judgm^{ts} obtained; Ordered that it be Referred to M^r Attorney and Sollicito^r Gen^{ll} whether such Conveyances may be deemed legall and to Advise what way may be most suitable & proper for his Ma^s Service to obstruct and hinder such ffraudulent Conveyances, whereby those Judgm^{ts} may Effect the Estates of those p^rsons ag^t whom they are obtain'd from the time of their first passing, and that they make Report thereon accordingly with all Convenient Speed.
