The Juro<sup>rs</sup> being called & answering all of them to their call, by [p. 15] their seuerall names, The fforeman deliuers in their Verdict (Viz)

That Patrick Due is not Guilty of th<sup>e</sup> murder whereof hee stands indicted in the Bill. Butt wee find him Guilty of Manslaughter.

Vppon w<sup>ch</sup> their Verdict, Proclamaõn was made, How th<sup>t</sup> if any one can informe of any other felony, or misdemeano<sup>r</sup> committed or done by Patrick Due, now Prisoner att th<sup>e</sup> Bar, Lett him Come forth, & shall bee heard, for th<sup>e</sup> Prisoner standeth uppon his Justificaõn & deliuerance

And Tobias Dunkin, Elias Chandler & John Adams came afore the Board, & declare for th<sup>e</sup> Lord Proprietary (Intimating w<sup>th</sup>all that they could say noe more then what they had allready declared & affirmed) And enter into new Recognizances.

Whereupon th<sup>e</sup> L<sup>t</sup> Gräll adiorned th<sup>e</sup> Court till th<sup>e</sup> Eighth day of this p<sup>r</sup>sent month; And to bee held att S<sup>t</sup> Maries. The Prisoner againe Committed to Prison.

Warr<sup>t</sup> to the sheriffe of Caluert County to summone Thirty men att least out of that County, to attend th<sup>e</sup> Gou<sup>r</sup> & Councell as Juro<sup>rs</sup> att S<sup>t</sup> Maries, on th<sup>e</sup> 8<sup>th</sup> of this instant, according to th<sup>e</sup> s<sup>d</sup> adiorn<sup>t</sup>. And then Ret.

Mathew Stone Gent<sup>n</sup> dds war<sup>t</sup> ag<sup>st</sup> Lieut<sup>t</sup> John Bogue accõn Case. Aprill p<sup>o</sup> war<sup>t</sup> to th<sup>e</sup> sheriffe of Caluert County to arrest & c: Ret. next Prouinciall Court to bee held 2<sup>o</sup> Junij.

Co<sup>t</sup> George Waters & Jacob Direckson Millray (p<sup>r</sup> Attornat Cap<sup>t</sup> Aprill 4<sup>o</sup> James Neale) dd writt ag<sup>st</sup> Cap<sup>t</sup> Miles Cooke accõn Case, to the ualew of 20000<sup>t</sup> Tob.

War<sup>t</sup> mde to sheriffe S<sup>t</sup> Maries County to arrest & c: Ret next Prouinciall Court 2<sup>o</sup> Junij ut supra.
