

Regulacon & good Govⁿm^t of Trade & other Matters exigences & things within y^e sd p^oincts as to y^m or y^e Major p^ote of them shall seeme meete so as they be Consonant to Reason & not contrary but as neere as Conveniently may be agreeable to y^e Lawes Statutes & Customes of England & of y^e sd p^ovince of Maryland w^h sd By Lawes & Ordinances being ratified & Confirmed by our selfe or our heires or our Lieutenant of y^e sd Province for y^e time being shall be observed kept & performed by all mann^r of p^ons trading & liveing within y^e sd Citty under such reasonable paines penaltyes & forfeitures as shall be imposed by y^e said Major Recorder Aldermen & Comon Councill or the Major part of them then assembled from tyme to tyme the said paynes, penaltyes & forfeitures to be raised by distresse and Sale of the Goods of such person soe offending and to be employed for the publique benefitt of the said Citty att their discrecon w^h sd By Lawes and Orders shall be alsoe repealeable or lyable to be mittigated or altered att y^e Will of our selfe our heires or our Leiutenn^t Respectively And further wee Grant & give Licence to y^e Major Recorder Aldermen & com^on Councill of y^e sd Citty for y^e tyme being & their Successors forev^r to have and to hold one m^rkett weekely within y^e sd Citty on ev^ry Saturday in y^e sd weeke in some Convenient place to be by y^m appointed within y^e p^oincts of y^e sd Citty And alsoe one faire yearely to be kept on y^e three & twentieth day of ffebruary in ev^ry yeare for y^e Sale & vending of all mann^r of goods Cattle m^rchandize & all other Commodities w^hsoev^r & to sett such a reasonable Toll upon such goods Cattle m^rchandize & other Commodities as shalbe sold therein respectively as shalbe thought fitt by our selfe our heires or our Leiutenn^t of our sd p^ovince for y^e tyme being And shall & may alsoe have & hold a Court of Pypowdry during y^e sd ffaire for the det^rminacon of all Controv^sies & quarrells w^h may happen therein according to y^e usuall Course in England in y^e like Cases And wee Grant unto y^m all p^ofits & p^oquisitte due incident & belonging to y^e sd Markett ffaire & Court of Pypowder Provided allwaies y^t if y^e sd Major or Recorder so chosen or to be chosen from tyme to tyme as aforesd or either or any of y^m shall att any tyme hereafter misbehave him or themselves in y^e Execucon of their or any of their sev^rall & respective office or offices in y^e Judgm^t of ourselfe or our heires or our Leiutenn^t of the sd p^ovince for y^e time being And y^t wee or our heires or our Leiutenn^t of y^e sd p^ovince for y^e tyme being shall direct & signify under our his their or any of their hands & Seale hands & Seales hands to y^e Aldermen of y^e sd Citty or any two of them that it is our his or their pleasure that such Major or Recorder Respectively soe misbehaveing them or y^mselves shalbe removed or disposed from ye execucon of his or their respective office or offices respectively that then & imediately after such significacon y^e Authority & power hereby Given to such
