selfe to owe & stand indebted unto Thomas Bright of the Island of
Kent in th^e Prouince abouesd Plant^r him his heires executors Admin-
istrators or Assignes the full & iust some of three thousand One hun-
dred thirty & two pounds of sound m^rchantable tobacco in Caske to
be paid upon th^e Island of Kent aforsd for a valuable Considera^on
by me allredy receiued: One thousand in Caske to be payd th^e xth day
of October MDClxxi: And One thousand in Caske to be payd th^e
xth day of October Anno MDClxxii: And One thousand one hun-
dred thirty & two in Caske to be payd th^e xth day of October Anno
q̄ do^m MDClxxiii: for the which sd Payments well & truely to bee
made & donn, I th^e sd John Maggisson doe binde & sett ouer, from
me my heires exepto^{rs} or Administrators unto the abouesd Thomas
Bright his heires exepto^{rs} or Administrato^{rs} my Planta^on Lyeing
upon th^e Island of Kent aforesd in th^e Prouince abouesd And allsoe
one Cow Called Cherrey: & one Cow called Gentle: & one Heiffer
called yonge Gentle wth all theyer Feather increas the sd Cattell being
marked as followeth: the left eare Cropt, the right eare ouer keeld
& under keeld: And allsoe one Gunn: And one shagg Rugg the w^{ch}
sd Planta^on, Cattell & theyer increase: the gunn & Rugg: upon th^e
nonpayment of th^e sd tobacco as abouesd unto th^e sd Thomas Bright
his heires or assignes, by the sd John Maggisson his heires exepto^{rs}
or Administrat^{rs} are for euer to be & remayne to th^e only Proper
use & behoofe of him th^e sd Thomas Bright his heires exepto^{rs} Ad-
ministrato^{rs} or Assignes without any hinderance mollesta^on or lett
of me th^e sd John Maggisson my heires executo^{rs} Administrators
or Assignes, Or without any further truble in law it may & shall be
Lawfull for him th^e sd Thomas Bright or any by his order to enter
upon the said Land & Planta^on, as of his or theyer owne, And
allsoe the Cattell wth there increase as abouesd, And the Gunn &
Rugg as abouesd: In wittnes whereof I the sd John Maggisson
p^rtie to these p^rsents haue hereunto sett my hand & scale Interchang-
ably this xith day of August Anno q̄ do^m MDClxx: These words
