The marke of Macum Thomas vitz slitt of each ear & a Lardge under bitt of th^e right ear recorded th^e 13th octob^r 1666

The marke of Anne Ingram th^e relict of Robert Ingram, vitz, Cropt of both ears & one slitt of th^e right ear recorded th^e 6th November 1666

The marke of James Came, vitz, Cropt of both eares & overhalfd of both eares recorded th^e 13th November 1666

The marke of Jinkin Prise, vitz, Cropt & slitt of th^e right ear & underhalfd of th^e left recorded th^e 13th November 1666

The marke of William Cheeseman, vitz, two Notches each side of th^e ear both ears alike marked recorded th^e 20th November 1666

The marke of Allexander Jemison, vitz Cropt & one slitt on th^e left ear & a halfe moone on th^e upper side of th^e right ear & a nick underneath recorded th^e 26th November 1666

The marke of William Robbinson sonne in lawe to Allexand^r Jemison, vitz, Cropt & one slitt upon th^e left ear & a halfe Moone upon th^e foreside of th^e right ear recorded th^e 26th Novemb^r 1666

The marke of David Spence, vitz, Cropt of both ears and two slitts in th^e left ear recorded th^e 26th November 1666

The marke of Allexander Mitcheller, vitz, the right ear slitt & th^e left ear Cropt & one hole in itt recorded this 26th November 1666

The marke of John Bun, vitz, Cropt of both ears A hole in th^e right & underhalfd of both ears recorded th^e 30th November 1666

The marke of Steven Horssi, vitz, Cropt of th^e right ear & one slitt in th^e Left ear recorded th^e 4th November 1666

[p. 10] The marke of William Greene vitz th^e right ear Cropt & an underbitt & an overbitt of th^e same ear the left ear a flower deluce recorded th^e 21th December 1666

The marke of Christopher Nutter vitz, Cropt of both ears three slitts in th^e right & two in th^e left recorded this 31th xb^r 1666 Nota th^t Christopher Nutter having entered a marke in Folio (5) being th^e third marke stands for Nothing in regard itt was entered by m^r Henry Boston in folio (4) being th^e 15th Marke in th^t folio, th^e w^{ch} marke in folio (5) marke th^e (3) Christopher Nutter disowneth

The marke of John Peter & Edward Dickenson th^e sonns of Edward Dickenson Cropt of both ears over bitt of th^e right ear & a slitt in th^e crop of th^e right & underbitted of th^e left recorded th^e 14th Jan^r 1666
