Sep^t 8th Then Lycence was granted to Tho: Snow to kill any wilde Cattle and hoggs unmarkt on any part of the North side of Chester riuer, and to reserue the hydes and tallow for his lordps use, the s^d Lycence to endure for one yeare from the date thereof

Octob^r 2^d Came Richard Moy and desires the marke of his Cattle may be Recorded which is as followeth (uizt) Swallow forkt the right eare and cropt wth three slitts in the left eare

The Oath of a Deputy Surveyor

I A. B. doe sweare th^t I will well & truly Serve th^e Right Honb^{le} Caecilius lord Baltmore Absolute Lord & Prop^{ty} of this province of Maryland &c in the Office of a Surveyo^r under Jerome white Esq^r Surveyo^r Geñall of the sd Province, I will doe Right according to th^e uttmost of my skill & power to his lo^p & to all manner of people poore & Rich who shall be concerned in taking up of lands by v^tue of his Lo^{ps} Condiçions of Plantaçon within the sayd Province wthout favour or Affecçon hatred or malice to any person or persons whatsoever I will without delay well & duely execute all such Warrants & Orders as shall come to my hands from his s^d Lo^p or his Lo^{ps} Leiv^tenn^t Geñall for th^e time being or other person autho^rzed & appoynted by them or either of them for th^e granting of warr^{ts} for Surveyghing or laying out of any of his lo^{ps} lands wthin the sd Province & returne due certificate therof unto the Seçtarys Office of this Province I will increase noe Feas nor directly or indirectly exact demand receive or take any Reward of or from any manner of person or persons whatsoever for to do wright or Wronge other then the usuall allowed Fees appointed for th^e Surveyo^r geñall or such as his sayd löpp shall Order & appoint And shall be accomptable to th^e said Jerome White for halfe of all such Fees soe earned by mee as Surveyo^r & with th^e other halfe shall be contented having noe Regard to other profit or Advantage to mee or any other person lastly I doe sweare well & truely to performe & Comply with all & eüy clause & p^ticuler exprest & sett downe in my Commission received from th^e said Jerome White for th^e Employ^t of Deputy Surveyo^{rs} as alsoe with whatsoeü is declared in one certeyne Bond given under my hand & seale for the due p^fformance of the sd Employ^t & to Observe & Keepe all that is required in any act or Acts of Assembly relating or any waies concerning the Surveyo^r geñall of this Prov-
