

Twentieth day of february in the yeare aforesayd the said Sarah the wife of the said Nicholas did byte and her the said Sarah did Teare and greivously wound of w<sup>ch</sup> wounds she did a long time languish whereby the said Nicholas did Expend diverse and greate sumes in and about the curing of the said wounds, and other Enormityes did then & there doe to the greate damage of them the said Walter & Sarah and Contrary to the peace & whereupon they say they are Damnyfied and have losse to y<sup>e</sup> vallue of foure Thousand pounds of Tobacco and thereupon they bring their suite. And the said Tobyas Miles by George Parker his Attorney doth come & defend the force and injury when &c and saith that he is in no wise guilty of the p<sup>r</sup>mises in manner & forme as the p<sup>t</sup> in his Declaration hath Declared and of this he puts himself upon the Country and the said Nicholas and Sarah likewise.

Therefore comaund is given to the Sheriff of St Maryes County that he Cause to come before the Justices of the Provincial Co<sup>rt</sup> at the City of St Maryes the Eleaventh day of November next being the first day of y<sup>e</sup> same Co<sup>rt</sup> twelve &c by whom &c who neither &c because aswell &c to Recognize &c and the same day is given to both ptyes. At w<sup>ch</sup> said Eleaventh day of November the Provincial Court aforesayd was by the writ of Adjournm<sup>t</sup> of the said Lord Proprietary adjournes untill the next day being the Twelveth day of the same November.

At w<sup>ch</sup> said twelveth day of November in the 42<sup>th</sup> yeare of the Dominion of Caecilius &c Annoq̄ Domini 1673. came aswell the aforesayd Nicholas Carre & Sarah his wife by John Morecroft their Attorney as the said Toby Miles by George Parker his Attorney and the Juro<sup>rs</sup> of that Jury likewise Came to wit Demetrius Cartwright John Hollins Henry Spry William Watts Richard Whitley George Charlesworth Edward Wincles William Whittle Henry Beedle Thomas Courtney Thomas Bennet & John Barbour who to say the truth in the p<sup>r</sup>mises being elected tryed & sworne upon the oathes doe say that they finde for the Defend<sup>t</sup> with costs of suite. wherefore it is Considered by the Co<sup>rt</sup> here that the said Toby Miles Recover ag<sup>t</sup> the said Nicholas Carre and Sarah his wife the sum of \_\_\_\_\_ pounds of Tobacco for his costs and Charges in this behalfe vexatiously Expended and that the said Nicholas & Sarah lose their writ and be in mercy for the false complainte and the Court doe ord<sup>r</sup> the Jury to be payd One hundred & Twenty pounds of Tob a peice in all 1440<sup>t</sup> Tob for their attendance.

Thomas Knighton of Ann Arundell County gentl being subpenaed this Co<sup>rt</sup> as a witnes between Henry Beedle & Sophia his wife p<sup>ts</sup> and George Wells defend<sup>t</sup> on the behalfe of the said Wells petitions the Co<sup>rt</sup> for his Charges this Co<sup>rt</sup> and the last Co<sup>rt</sup> being then also subpenaed.
