

At a Session of ASSEMBLY begun and held at the City of *Annapolis*, on Saturday the 22d Day of *March*, and ended on Friday the 11th Day of *April*, in the 9th Year of the Dominion of the Right Honourable FREDERICK, absolute Lord and Proprietary of the Provinces of *Maryland* and *Avalon*, Lord Baron of *Baltimore*, &c. Annoq; Domini 1760: The following Laws were Enacted.

C H A P. I.

C H A P. VI.

An Act to aid some Proceedings of the Vestry of Port-Tobacco Parish, in Charles County; and to impower the said Parish to elect Vestry-men and Church-wardens. Lib. H.S. fol. 382. OBS. Ditto.

N. B. Easter Monday 1759, being very Rainy, so as the Vestry cou'd not meet to proceed in the Election of Vestry-men and Church-wardens, so that the Parish was not, from that Time, fully represented; notwithstanding which, the Vestry had transacted the Parish Business: This Act makes valid the Vestry Transactions in 1759, so far as relates to Taxing of Batchelors and chusing Inspectors, and enables the Parish to elect four new Vestry-men, and two Church-wardens, &c.

C H A P. VII.

An Act to increase the Salaries of the Inspectors of Snow-Hill Warehouse in Worcester County, and Plymouth Warehouse in Dorchester County. Lib. H.S. fol. 383. EXP. Ditto.

An Act for the speedy and effectual Publication of the Laws of this Province; and for the Encouragement of Jonas Green, of the City of Annapolis, Printer. Lib. H.S. fol. 384. EXP. Ditto.
