N. B. This *Edward Husbands*, being charged with an Attempt to poison the Governor, and  
 the Upper and Lower Houses of this Assembly, was by this Act utterly disabled, and made inca-  
 pable of ever practising in his Profession as a Physician or Chirurgeon within this Province, un-  
 der Penalty of 200 l. Sterling, for every Time he should presume to practice as aforesaid; and al-  
 so to be bound over to the next Provincial Court, to answer the Premises, and in the mean Time  
 to be of good Behaviour, &c. And for his Menacing and Cursing the Assembly, to receive 20  
 Lashes on the bare Back, by the Hands of the common Hangman, &c.

Memorandum: His Lordship's Proclamation of Dissent to all and every Act and Acts of Assem-  
 bly, made in this Year, such only excepted as his Lordship (since his Arrival here) by his Assent  
 in a General Assembly, had continued, confirmed, or revived, which are also to stand continued  
 or revived to all Intents, &c. is dated the 5th May 1684. C. O. fol. 101.
