Now here att this day to witt the Eighteenth day of November in the Tenth Year of the reigne of King William the third of England Annoque Dni 1698 Came the Said Clement Sale by Robert Gouldsborough his Attorney and prayed that the Said John Salter to his Decl^{af} might Answer And the Said John Salter by W^m [Dent] his Attorney Coms and defends the force and Injury when etc. [and] Saith that he Cannot Gainsay the Acc^o of the pl^t So brought ag^t him as af^a Whereupon it is Considered by the Court that the Said Clement Sale recover ag^t the Said John Salter as well [the] Summe of Thirteen Thousand four hundred Seaventy one p^{ds} of Tobb^a his debt aforesaid as also the Summe of Six hundred Eighty Seaven pounds of Tobb^a and the defend^t in mercy [etc.]

[130] Command was given to the Sherriffe of Kent County That he take John Salter if he be found in his Bayliwick and him Safe keep So that he have his Body before the Justices of the Prov^l Court the Second Tuesday of May next to Satisfy unto Clement Sale as well the Sume of Thirteen Thousand four hundred Seaventy one pounds of Tobbacco a Certain Debt recovered of him whereof he is Convict as also the Summe of Six hundred Eighty Seaven pounds of Tobbacco Cost of Suite whereof he was not to faile and to have then and there the Said Witt Wittness Robert Smith Esq^r Chief Justice of the Said Court the 19th day of November in the 10th Year of his Matys Reigne Annoque Dni 1698.
