The Department administers the Data Center for public safety, law enforcement, and correctional agencies within the State. The Data Center currently provides data processing services to the State Police, Division of Correction, Division of Parole and Probation, Patuxent Institution, Juvenile Services, and local agencies. It provides computer terminal and computer-to-computer data transmission between Maryland Criminal Justice agencies and the Federal Bureau of Investigation, State Motor Vehicle Administration, Baltimore City Police Department, the National Law Enforcement Telecommunications System, and the Washington, D. C. area law enforcement computer system furnishing law enforcement and other data stored in these systems to the inquiring agency (Code 1957, 1971 Repl. Vol., Art. 41, secs. 204-204E).
