The Governor appointed this Commission in 1976 at the request of the General Assembly for the purpose of studying the institutional and community-based needs of the mentally retarded. The Commission consists of members of the General Assembly, two representatives from the Maryland Association for Retarded Citizens, Inc., one from an independent provider of residential services, the Director of the Mental Retardation Administration, a representative of the State Developmental Disabilities Council, a representative from the Rosewood Association for the Retarded, and a superintendent of a State-operated institution for the retarded. The Commission is to develop a long-range plan for residential services for Maryland's retarded citizens and to investigate the relationship between expenditures for State institutions and community-based residential programs. The Commission is to report to the Governor and the General Assembly no later than February 1, 1977 (Res. No. 19, Acts of 1976).
