

perform administrative duties in each of their respective circuits, with the aid of county administrative judges.

Each Circuit Court judge initially is appointed to office by the Governor and then must stand for election. The judge's name is placed on the ballot of the first general election that occurs at least one year following the vacancy he or she was appointed to fill. The judge may be formally opposed by one or more qualified members of the bar, with the successful candidate being elected to a fifteen-year term of office (Const. 1867, Article IV, secs. 19–26).
