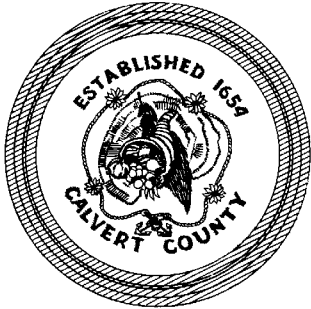

CALVERT COUNTY
