The Governor's Prescription Drug Commission was created by the Governor in March 1990 (Executive Order 01.01.1990.07). The Commission is to develop and implement a program to curb the diversion of prescription drugs into unlawful channels and to reduce the abuse and misuse of such drugs.

The Commission will make recommendations concerning the State's efforts to reduce the diversion, abuse and misuse of prescription drugs. The Commission also will consider a regional drug review program for the mid-Atlantic states to collect and compile data on patterns of improper prescribing or dispensing of prescription drugs.

The Commission consists of nineteen members appointed by the Governor.
