Annual Report to Court of Appeals.

The Clients' Security Trust Fund of the Bar of Maryland was established to reimburse clients for losses caused by defalcations of members of the Bar

of the State of Maryland, acting either as attorneys or fiduciaries (except to the extent to which they are bonded). The Fund is supported by annual assessments upon members of the Bar as a condition precedent to the practice of law.

Appointed to seven-year terms by the Court of Appeals, eight trustees oversee the Fund (Md. Rules, Rule 1228).
