The Governor's Office of Crime Control and Prevention was created in 1995 by the Governor to address concerns about public safety and the prevention of crime and substance abuse (Executive Order 01.01.1995.18). The Office was formed by merging the functions of the Office of Justice Administration and the Governor's Drug and Alcohol Abuse Commission.

For nonprofit community groups and local and State government agencies, the Office administers State grant programs, including the *Governor's Drug and Alcohol Abuse Program* (also known as Neighborhood Crime Prevention Grants); and the Maryland Victims of Crime Fund. The Office also oversees several federal grant programs, including the *Edward Byrne Memorial State and Local Law Enforcement Assistance Program*; the *Juvenile Justice and Delinquency Prevention Program*; the *Violence Against Women Program*; the Police Victims of Crime Fund; and the Governor's portion of the federal *Safe and Drug-Free Schools and Communities Program*.

The Office helps draft legislation, policies, plans, programs, and budgets to improve public safety and the administration of justice and reduce and prevent crime, violence, delinquency, and substance abuse. It also receives policy direction and oversight from the Cabinet Council on Criminal and Juvenile Justice.

Appointed by the Governor, the Executive Director serves on the Criminal Justice Information Advisory Board and the State Board of Victim Services.

The Juvenile Justice Program administers funding and provides technical support to carry out State, local and private nonprofit programs. These programs seek to treat serious and chronic juvenile offenders, improve the juvenile justice system, and prevent delinquency.
