EMERGENCY RESPONSE & ENVIRONMENTAL SURVEILLANCE DIVISION

Formerly under the Radiological Health Program in the Air and Radiation Management Administration, its functions were transferred to the Technical and Regulatory Services Administration in 1995.

EMERGENCY RESPONSE DIVISION

Formerly under the Environmental Response and Restoration Program of the Waste Management Administration, the Division became the Emergency Operations Division under the Emergency Operations and Technical Support Program of the Technical and Regulatory Services Administration in 1995.

ENFORCEMENT DIVISION

Formerly with the Water Resources Administration of the Department of Natural Resources, the Division transferred to the Department of the Environment and incorporated into the Inspection and Compliance Program of the Water Management Administration in 1995.

ENFORCEMENT PROGRAM

Under the Air and Radiation Management Administration, renamed Air Quality Compliance Program in 1995.

ENGINEERING & CONSTRUCTION PERMIT PROGRAM

Under the Water Management Administration, renamed Water and Wastewater Engineering Program in 1995.

ENGINEERING DIVISION

Under the Air Quality Permits Program, renamed Combustion and Metallurgical Division in 1995.

ENVIRONMENTAL ASSESSMENT PROGRAM

Under the Chesapeake Bay and Watershed Management Administration, reorganized in 1994 as Mathematical Modeling and Information Systems Management.

ENVIRONMENTAL BOARDS, TRAINING, & TECHNICAL ASSISTANCE DIVISION

Formerly under the Water Management Administration, disbanded in reorganization of 1995.

ENVIRONMENTAL HEALTH ASSESSMENT & SURVEILLANCE

Formerly under Environmental Health Coordination, its functions transferred in 1995 to the Toxics Assessment Division of the Environmental Risk Assessment Program in the Technical and Regulatory Services Administration.

ENVIRONMENTAL HEALTH COORDINATION

Abolished in 1995 and its functions dispersed to the Technical and Regulatory Services Administration and the Waste Management Administration.

ENVIRONMENTAL NOISE ADVISORY COUNCIL Formerly under the Air and Radiation Management

Formerly under the Air and Radiation Management Administration, the Council has been inactive for many years.

ENVIRONMENTAL RESPONSE & RESTORATION PROGRAM

Under the Waste Management Administration, reorganized as the Environmental Restoration and Redevelopment Program in 1995.

At the request of the House Environmental Matters Committee, the Secretary of the Environment convened the 15 Percent Plan Task Force in July 1995. The Task Force advised the Department on how the State could meet the 1996 deadline for reducing emissions of volatile organic compounds (VOCs) by 15 percent as required by the federal Clean Air Act. Maryland's original 15 Percent Plan relied on the Vehicle Emissions Inspection Program to reduce emissions significantly; however, when the mandatory dynamometer test was postponed, alternative methods were needed. The Task Force submitted its final report January 30, 1996.

Formerly under Finance and Administration, reorganized in 1995 as Information and Communications Systems Division under the Administrative and Employee Services Administration.
