[486] Therefore it is Considered by the Court that the Said Robert Mason Plaintiff takes nothing by his Seid writt but be in mercy for his falce Clammour and lett the names of the Pledges be Sought for and the Said William Stimpson Defendant goe thereof without day etc.

It is Likewise Considered that the Said William Stimpson Defendant doe recover against the Said Robert Mason Plantiffe for the Sume of three hundred and Nine lbs. of Tobacco his Damages by Occation of the Premisses by the Discretion of the Justices here to the Said William Stimpson for his Costs and Charges by him in this Part Sustained according to the forme of the Statute etc. by the Court here adjudged. etc.

The Plantife by William Stone his attorney Brought his Majestys writt against the Defendant in a plea of tresspass upon the Case etc. it being for fourteen hundred and twenty pounds of Tobacco due upon the Ballance of accounts And David Small Administrator of the Said Treacy by Joshua Cecell his Attorney cometh and Defendeth the force and Injury when etc. And Prayeth Leave to have auditors assigned him to hear and Adjust accompts between him and the Said Plantiffe According to an Ordinance of Assembly in Such Cases made and provided etc. And by the Court auditors are assigned him that is to Say Christopher Baines and Paule Bussey Who are hereby Ordered to here and adjust accompts between the Parties afforesaid and to returne their audict this affernoon.
