To all Christian and other People whom these presents may Concerne Know ye that I John Ackatomaka Emporer of Piscattaway for and in Consideration of the Sume of one hundred and Eight armes Lenth of Roanoake to me Paid by William Hutchison of Prince Georges County as also out of the Speaciall Love and Favour I bear to the Said William have given Granted Sold and assigned and by these presents doe give grant Sell assigne and Make over unto him the Said William Hutchinson a Certaine parcell of Land Laying upon Patomick River Adjoyneing to Pamonkey Creek Extending it Self from the Said Creeke up the River to a great Marsh about a Mile from the Said Creek and not Extending it Selfe
