- An ACT to authorize and empower the justices of Prince-George's county to assess and levy on the inhabitants of said county, the sum of one hundred and fifty pounds current money, for the purposes therein mentioned. XXVIII.
- An ACT for the division of Washington county, and for erecting a new one by the name of Allegany. XXIX.
- An ACT to carry into execution a resolve of the congress of the United States respecting the safe-keeping of persons committed under the authority of the United States to gaols of this state. XXX.
