or Assignes they or any of them doo well and truly content satisfy and pay all the debts due and owing by Samuel:
Jumb of this County deceased upon Order had and obtained from their Malis Justices of the Peace in Court
sitting as also to observe the clause and clauses in the said Wth of Administration already granted to the said
Morris, as also to make no waste sale or disposition in or upon the real Estate or parts viz: soeiling heafes out
heafes, Land woods, Orchards and founts. Observing that Law intituled an Act for preservation of Cephauls real
Estate. And lastly to keep harmless the Justices of the Peace of the said County for probat of Wills granting
of Administrations and all other the Officers that then this Obligation to be void and of none effect through
to be and remain in full power force and virtue.
