

CIAL STATUS AND ACTIVITIES: Esq. on arrival; apparently left Maryland between April 10 and May 1, 1643, and did not return. PUBLIC CAREER. LEGISLATIVE SERVICE: Assembly, special writ 1642A, probably a special writ 1642B (did not attend). OTHER PROVINCIAL OFFICES: Council, 1642-1643; justice, Provincial Court, 1642-1643. MILITARY SERVICE: captain, 1642-1643; commander, St. Mary's County Militia, 1642.

**BLUNT, RICHARD** (ca. 1621-1669). BORN: probably in England. IMMIGRATED: in 1649 as a free adult. RESIDED: in Kent County. MARRIED Ann. CHILDREN. SONS: Samuel; Richard; Josias; Robert; and Thomas. DAUGHTERS: April; Grace; and Rebecca. PRIVATE CAREER. EDUCATION: illiterate. SOCIAL STATUS AND ACTIVITIES: not called Mr. prior to holding office. OCCUPATIONAL PROFILE: planter. PUBLIC CAREER. LEGISLATIVE SERVICE: Lower House, Kent County, 1662, 1666, 1669. LOCAL OFFICES: sheriff, Kent County, 1662; justice, Kent County, 1666-1669. WEALTH DURING LIFETIME. LAND AT FIRST ELECTION: 330 acres, 1650; 530 acres by 1669. WEALTH AT DEATH. DIED: on September 16, 1669. PERSONAL PROPERTY: TEV, 43,629 pounds of tobacco; FB, 27,190 pounds of tobacco. LAND: 530 acres.

**BOARMAN, HENRY** (?-1800). BORN: of age by 1772; only son. NATIVE: at least second generation. RESIDED: in Bryan Town Hundred, Charles County. FAMILY BACKGROUND. FATHER: James Boarman. MOTHER: Mary Pile (?-1791). SISTER: Elizabeth, who married Edward Boarman (?-by 1800). MARRIED Theresa (?-1801), daughter of Richard Edelen (?-1803) and wife Sarah Harrison. Her brothers were Richard, Jr.; Philip; and Samuel. Her sisters were Rachel, who married (first name unknown) Gardner; Jane, who married (first name unknown) Mudd; Dorothy, who married (first name unknown) Gardner; Elizabeth; and Araminta. CHILDREN. Died without progeny. PRIVATE CAREER. EDUCATION: literate. RELIGIOUS AFFILIATION: wife bequeathed money to the Catholic archbishop of Baltimore. OCCUPATIONAL PROFILE: probably a planter. PUBLIC CAREER. LEGISLATIVE SERVICE: Lower House, Charles County, 1780 (elected, but did not attend; resigned on November 2, 1780). LOCAL OFFICE: Committee of Observation, Charles County, elected 1775. MILITARY SERVICE: 1st lieutenant, Third Maryland Battalion of the Flying Camp, July-December 1776; captain, Twelfth Battalion, Charles County Militia, commissioned 1777. WEALTH DURING LIFETIME. PERSONAL PROPERTY: assessed value

£477.0.0, including 11 slaves; 17 slaves, 1790; inherited 9 slaves from his mother, 1791; 35 slaves, 1798. LAND AT FIRST ELECTION: 436 acres in Charles County, 1783. WEALTH AT DEATH. DIED: in June 1800 in Bryan Town Hundred, Charles County. PERSONAL PROPERTY: TEV, \$5,976.80 (including 37 slaves and 30 books). LAND: 280 acres in Charles County, 1798; disposition of his estate was contested by his sister's family, 1801-1819.

**BOND, BENSON** (1710-1750). BORN: on September 25, 1710, in Calvert County; second son. NATIVE: at least second generation. RESIDED: in Calvert County. FAMILY BACKGROUND. FATHER: Richard Bond (?-1719), of Calvert County. MOTHER: Elizabeth (?-1725), widow of Benjamin Chew (?-1700), of Anne Arundel County. BROTHERS: Richard (1707-?); Thomas (1713-?); John (1715-?); and Phineas (1717-?). HALF BROTHER: Samuel Chew (by 1700-?). SISTER: Sarah (1708-?). HALF SISTERS: Mary Chew (by 1700-?); Eliz Chew (by 1700-?). MARRIED Mary (1713-?), daughter of *Thomas Holdsworth* (ca. 1692-1718); stepdaughter of *Benjamin Mackall* (1675-1761); niece of *Walter Smith* (ca. 1693-1748); half niece of *John Rousby* (1685-1744); stepniece of Ann Mackall (1661-?), who married *Robert Skinner* (?-1713). Her half brother was *Benjamin Mackall, Jr.* (ca. 1723-1795). Her sisters were Betty (1715-?), who married *James Heighe* (?-1757); Rebeka (1716-?); and Ann (1719-?). Her half sister was *Barbara Mackall* (1722-?), who married *William Wilkinson* (?-1755). Her half first cousins were Ann Rousby (1721-1769), who married *Edward Lloyd* (1711-1770); Elizabeth Rousby, who married *Abraham Barnes* (?-ca. 1778); and Gertrude Rousby (?-ca. 1770), who married *Robert Jenkins Henry* (ca. 1712-1766). Her half nephew was *William Mackall Wilkinson* (1752-1799). CHILDREN. SONS: Richard; Thomas. DAUGHTERS: Elizabeth; Barbary (Barbara). PRIVATE CAREER. EDUCATION: literate. RELIGIOUS AFFILIATION: uncertain, but the Bond family is listed in early Quaker records. SOCIAL STATUS AND ACTIVITIES: Gent., 1749; Mr. at death. OCCUPATIONAL PROFILE: possibly a planter. PUBLIC CAREER. LEGISLATIVE SERVICE: Lower House, Calvert County, 1749-1750 (died before the 3rd session). WEALTH DURING LIFETIME. LAND AT FIRST ELECTION: inherited unspecified acreage in Calvert County from his father in 1719, possibly more than 200 acres. WEALTH AT DEATH. DIED: in July 1750 in Calvert County.
