

For Fredericksburg, Alex. Falls & Co. agents, No. 3 and 4, Light-st wharf. The Rappahannock, Capt. Fairbank, leaves lower end of Light-st wharf, every Sunday morning at 6 o'clock, for Fredericksburg, Va.; arrives here every Thursday afternoon.

Rappahannock leaves on Wednesday morning, for Fredericksburg, and arrives on Sundays at 2 P. M.

The Maryland, Capt. Lemuel G.
