We the Subscribers having being first Qualified to execute the within Commission and having also first given twenty days Notice for the Execution thereof Agreeable to Act of Assembly we have proceeded to take the several Depositions hereunto annexed all which we have by us taken under our hands and Seals the Twenty fourth Day of January Anno Domini 1761 -

being sworn on the holy Evangelist of Almighty God Depoeth that about thirty four years ago that he this Depoent had a Commission to survey the Bounds of a tract of Land called Second Choice and he this Depoent called upon the following persons to view the third and fourth Bound of Second Choice William Alexander, Peter Sherman, George Goddard, William Brasen, Thomas Brasen and Charles Muller - but they said they did not know where they were and further this Depoent saith that he never could get any Intelligence where the third Bounders stood and further this Depoent saith that he saw the 24th day of January Anno Domini 1761 - *Prose* *The Holbrook*

The Deposition of William Pullet aged fifty years or there about being sworn on the holy Evangelist of Almighty God Depoeth that on the Ninth day of July Anno 1760 that Nicholas Divine told this Depoent that near or at this Place where the Subscribers are present that Abah Coster told the said Nicholas Divine that to the Best of his Knowledge that said Coster was a Division Bounder between him the said Abah Coster and Thomas Pullet and that he the said Abah Coster told the said Nicholas Divine that they Run to a Shipping Gun with a small Round Gun Ground from the Post standing to the North Side of the Gun thence along to an Old Path where there was a Great Pine standing and further the said Abah Coster told the said Nicholas Divine to take Notice of a White Oak that stands about Twenty feet from a Large Stone where we the Subscribers are now present and further this Depoent saith that he saw the 24th day of January Anno 1761 *Prose* *The Holbrook*

The Deposition of Charles Fitzwater aged thirty years or there about being sworn on the holy Evangelist of Almighty God Depoeth that about four or five years ago that Abah Coster told this Depoent that he the said Abah Coster had some of Thomas Pullet's Land and the said Coster told this Depoent to go and cut Timber on this Side of the Branch where we the Subscribers are present and the said Coster would keep this Depoent harmless and further this Depoent saith that he never heard Abah Coster say anything about any Bounder being where we the Subscribers are and further this Depoent saith that he saw the 24th day of January Anno Domini 1761 *Prose* *The Holbrook*
