BY THE SENATE, January 27, 1806.

GENTLEMEN OF THE HOUSE OF DELEGATES,

THE gentlemen appointed to count the ballots for a person to be recommended to the governor to be commissioned as register of wills for Saint-Mary's county, having reported that the ballot boxes were found, on examination, to contain more ballots than there were attending members of both houses when the boxes were sealed. The clerk of the senate delivers the engrossed bills Nos. 100, 108, 111, 112, 113 and 115, with the paper bills thereof, severally endorsed, "read and assented to."

The following resolution was read the first and second time by especial order, assented to, and sent to the senate by the clerk.

RESOLVED, That the treasurer of the western shore pay to Thomas Bayly, Esquire, one of the delegates from Somerset county, or to his order, seven dollars, for two days attendance, and to John Cottman, Esquire, a delegate from the same county, twenty-one dollars, for six days attendance, which sums have been omitted to be allowed them on the journal of accounts.

The house proceeded to ballot for a person to be recommended to the governor to be commissioned as register of wills for Saint-Mary's county; the ballots being deposited in the ballot box, the gentlemen named to strike retired, and after sometime returned and reported, that James Forrest had a majority of votes.
