Court.

ordered by this Court That John Gresham keep the said David James in  
safe Custody untill the fine aforesaid shall be satisfied

ordered by this Court that the said David James give Security for his ap-  
pearance to next Court and good behav<sup>r</sup> in the mean time.

And David James aforesaid in his proper person came into Court and acknowledged him-  
self indebted to the Right Hon<sup>ble</sup> The Lord Prop<sup>r</sup> that now is in the sum of Twenty  
pounds Sterling money of Great Brittain to the Officers of this said Lord Ship his heirs  
and Successors to be made and Levied on his Goods and Chattels Lands and  
Tenements Conditionally That if he shall not make his personall appear-  
ance at the next Court to be hold for said County on the third last day in March  
then next ensuing and in the mean time to be of good Behaviour wherewith he  
acknowledges himself content

And at this same time came William Simcocks and Thomas Raser both  
of the County of Platan and present in Court in their proper persons and they  
acknowledged themselves indebted to the Right Hon<sup>ble</sup> The Lord Prop<sup>r</sup> that  
now is in the sum of ten pounds Sterling money of Great Brittain each  
to be levied on their Goods and Chattels Lands and Tenements to the use of  
his said Lord Ship his heirs and Successors Conditionally That if the said David  
James shall not make his personall appearance at the next Court to be hold  
for said County on the third last day in March then next ensuing and in the  
mean time he is to be of good Behaviour wherewith the aforesaid William  
Simcocks and Thomas Raser acknowledge himself to be there with  
to be content
