Jovey Bonj Griffith William Doan Joshua Bock Nathaniel Hamard William Edmarsh Phillip Roberts who being duly elected tryd & Sworn to say the truth in the premises upon their Oath do say William Bannor is Guilty of the Felony as he stands Induted and by James Moore their foreman al so say. Therefore it is considered by the Court here to wit at the Court House in the Town of Chester in Said County on the third Tuesday in March being the eighteenth day of said Month Anno Domini one Thousand Seven Hundred and twenty eight That the afo William Bannor stand in the pillory for the space of half an hour and that afterwards he receive at the publick whipping post twenty and six strokes well laid on his bare back till the blood appears as a punishment for his afo Crime of Felony according to the force form and effect of the Verdict afo Also it is considered that the said William Bannor pay the Sum of five hundred and four pounds of Tobacco the four fold of the value of the goods afo being valued at one hundred and twenty six per of Tobacco. And also the Sum of eight hundred forty seven pounds of Tobacco Costs accruing on the premises afo to the officers of this Court

It is also considered by the Court here at this day to wit the same day and year last mentioned That the Sheriff of Kent County take the afo William Bannor into his Custody and execute the punishment in the Judgment afo specified and afterwards to bring him into Court again of which precept the Sheriff to wit John Gresham Gent High Sheriff of Kent County makes return on the day and year last said that he hath executed the said Judgment and also hath here ready the said William Bannor before the Court ordered by the Court here That John Gresham Gent High Sheriff of Said County keep the afo William Bannor in safe Custody until he shall pay the four fold in the Judgment afo mentioned and the Cost above specified
