 said Lord Proprietarie that now is his good rule and Government and against the form
 of the Act of Assembly in that case made and provided *Pharmin* Clerk Stat

AND the said Rebecca Hurt in her proper person came and said that she cannot
 gainsay the Indictment and so as against her brought nor but that she is guilty
 of the promises above upon her imposed as by the said Indictment it is alleged
 and thereupon submits to the Court *Therefore it is considered* by the Court
 here by at the Court House in the Town of Chester in said County on the third Wednesday in
 June being the seventeenth day of said Month Anno Domini One Thousand Seven
 hundred and twenty Nine That the said Rebecca Hurt pay the sum of thirty
 Shillings current money Debt according to Act of Assembly in such case made & pro-
 vided and also pay the sum of two hundred Twenty Six pounds of Tobacco Cash
 according to the premises and to the officers of this Court.

 born child in the said Indictment mentioned.

ordered by the Court here that Joseph Young Gent high Sheriff of said County
 keep the said Rebecca Hurt in safe custody until the fine and fees are
 paid as paid

ordered by the Court here that Warr. be made out to take the said
Pharmin Gilbert to answer unto the crime aforesaid

ordered by the Court here that Mr. Torch Francis Clerk of the Indictment
 of this Court Draw an Information ag^t the said *Pharmin* on and of the case born
 Child aforesaid
