

(A-1) FOR TAKING ANY WRITTEN EXAMINATION IN ORDER TO BE A REAL ESTATE BROKER, A FEE OF THREE DOLLARS (\$3.00).

(B) FOR EACH LICENSE AS REAL ESTATE BROKER ISSUED TO A MEMBER OF A PARTNERSHIP, ASSOCIATION, OR OFFICER OF A CORPORATION OTHER THAN THE MEMBER OF THE PARTNERSHIP OR ASSOCIATION, OR OFFICER OF THE CORPORATION NAMED IN THE LICENSE ISSUED TO SUCH PARTNERSHIP, ASSOCIATION, OR CORPORATION, A FEE OF TEN (\$10.00) DOLLARS, AND FOR EACH ANNUAL REGISTRATION OF SAID LICENSE THEREAFTER, A FEE OF TEN (\$10.00) DOLLARS.

(C) FOR EACH REAL ESTATE SALESMAN'S LICENSE, A FEE OF SEVEN DOLLARS AND FIFTY CENTS (\$7.50), AND FOR EACH ANNUAL REGISTRATION OF SAID LICENSE THEREAFTER, A FEE OF ~~FIVE (\$5.00) DOLLARS~~ SEVEN DOLLARS AND A HALF (\$7.50).

(D) FOR EACH ADDITIONAL OFFICE OR PLACE OF BUSINESS, AN ANNUAL FEE OF TWO DOLLARS AND FIFTY CENTS (\$2.50).

(E) FOR EACH CHANGE OF OFFICE OR PLACE OF BUSINESS, A FEE OF ONE (\$1.00) DOLLAR.

(F) FOR EACH CHANGE OF NAME OF LICENSEE ON THE RECORDS OF THE COMMISSION, A FEE OF ONE (\$1.00) DOLLAR.

(G) FOR EACH DUPLICATE LICENSE, WHERE, THE ORIGINAL LICENSE IS LOST, OR DESTROYED, AND AFFIDAVIT MADE THEREOF, A FEE OF TWO DOLLARS AND FIFTY CENTS (\$2.50).

(H) FOR EACH DUPLICATE OR TRANSFER OF SALESMAN'S LICENSE, A FEE OF FIFTY CENTS (\$0.50).

(I) FOR EACH DUPLICATE REGISTRATION, WHERE THE ORIGINAL CARD IS LOST OR DESTROYED AND AFFIDAVIT MADE THEREOF, A FEE OF ONE (\$1.00) DOLLAR.

(J) (FEES—NON-RESIDENTS.) NON-RESIDENT APPLICANTS IN STATES, TERRITORIES OR SUB-DIVISIONS OF THE UNITED STATES WHERE A SIMILAR LICENSING LAW IS IN EFFECT SHALL PAY THE SAME FEE OR FEES AND COMPLY WITH THE SAME REGULATIONS, INCLUDING THE MAINTENANCE OF A PLACE OF BUSINESS, THE LAW OF THEIR RESIDENT STATE OR TERRITORY REQUIRES OF A RESIDENT OF MARYLAND, PROVIDED SUCH FEE OR FEES SHALL IN NO CASE BE LESS THAN THOSE REQUIRED OF A RESIDENT APPLICANT.

231. (Suspension—Revocation of License.) (a) The Commission may upon its own motion and shall upon the verified complaint in writing of any person, provided such complaint, or such complaint together with evidence, documentary or otherwise, presented in connection therewith, shall make out a prima facie case, [investigate] *cause to be investigated* the actions of any real estate broker or real
