AND BE IT ENACTED, That there shall be an able and skilful man, experienced in assaying silver, ap- ath. pointed by the mayor and city council aforesaid, as assay officer for the said city, who previous to his acting as such, shall take the oath following to wit: I, A. B. do swear, that I will, so long as I shall continue an assayer, well and faithfully behave myself in the said office, and no undue profit to myself take, to the hurting or hindrance of any person that is owner or bringer in of any silver in plate to be assayed, and that I will touch no silver but what shall be of the goodness of eleven ounces pure silver to every pound troy; and all such silver as shall be brought to me to be touched, I will truly set down in writing, and the same at all times as I shall be required, will duly and truly deliver again, and will true accounts make thereof when thereupon required by the mayor or city council of the city of Baltimore; and that I will not assays make of things new wrought, before they be marked with the mark of the maker or owners thereof, so help me God; and shall also enter into bond to the mayor and city council aforesaid, in such sum, and with such securities, as they shall require, for the faithful and true performance of the duties
