And be it enacted, That it shall be the duty of the said Thomas account before Pearson, before he proceeds to execute or distrain the property of any person or persons for taxes, fees or public dues, in virtue of this act, to deliver to, or leave at the last place of abode of, such person or persons, his, her, or their executors or administrators, chargeable with the same, at least thirty days previous to levying such execution or distress, an account written in words at full length, of the taxes, fees or public dues, demanded of him, her or them, with an affidavit thereto annexed, if required, that he hath not received any part thereof, nor any thing in security or satisfaction for the same, more than the credit given, to the best of his knowledge.
