

project as constructed is not provided, with respect to sewer projects, beyond the area approved therefor. The program may be amended by the next annual revision, or an interim amendment may be accomplished by the following procedures. The Sanitary Commission may propose an amendment to a five year program by a resolution which shall before final adoption be transmitted along with a statement of explanation to the Maryland-National Capital Park and Planning Commission, and the same procedures followed with respect thereto as in Subsection ~~(e)~~ (B), above, provided, and if it involves a water or sewer line in Montgomery County by submission to the Montgomery County Council, with respect to which the procedures specified in Subsection ~~(d)~~ (C), above, shall apply.

(h) *Cooperation among the Counties and agencies.* It is the intention of the General Assembly that the Sanitary Commission, the Maryland-National Capital Park and Planning Commission, the County Council for Montgomery County and the Board of County Commissioners for Prince George's County shall cooperate to the fullest extent in seeking to attain maximum harmony of the water and sanitary sewerage construction programs with the other elements of orderly growth in the two Counties. The two Commissions, the County Council and the Board of County Commissioners are encouraged to meet and discuss the programs in discussion and work sessions, and the Sanitary Commission shall give to the County Council and the Board of County Commissioners such additional information and details, either orally or in writing, as the latter may request in connection with their respective considerations of the programs. [It is the intent of the General Assembly that the Sanitary Commission, the Park and Planning Commission and the County Council shall cooperate to the fullest extent and shall seek to attain maximum harmony of the sewer and water construction programs with the other elements of orderly growth in Montgomery County.]

(i) *Method of Sanitary Commission adoption.* The Commission's proposed programs and any amendment thereto shall be prepared and submitted as hereinabove recited. The adoption of the final five year program, each year, and of any interim amendment thereto, to be effective shall be by resolution of a majority of the members of the Sanitary Commission and, in addition, all the projects or portions thereof in each program proposed exclusively to provide service in Montgomery County and Prince George's County, respectively, shall be approved by a majority of the Sanitary Commissioners from the respective County. In finally adopting each five year water and sewer program or any interim amendment thereto the Commission shall amend its respective proposal where such amendment is required by the foregoing subsections of this section.

(j) *Prior Programs.* Any five year water or sewer program or any interim amendment thereto, adopted by the Commission prior to June 1, 1966, shall not be affected by the foregoing provisions. The Commission may construct any water or sewer project approved in a five year program adopted under the Five Year Program Law as it existed prior to the effective date of this Act (June 1, 1966), according to the terms and conditions of the approval, without regard to the foregoing provisions unless the project must be treated as a new one under subsection (b) hereof, in which event the provisions of that subsection shall apply.
