SECTION 1. *Be it enacted by the General Assembly of Maryland.* That Section 3 (u) of Article 33 of the Annotated Code of Maryland (1965 Supplement), title "Elections," subtitle "Supervisors of Elections and Employees," be and it is hereby repealed and re-enacted, with amendments, to read as follows:

SEC. 2. AND BE IT FURTHER ENACTED, THAT SECTION 159(H)(5) OF ARTICLE 2B OF THE ANNOTATED CODE OF MARYLAND (1965 SUPPLEMENT), TITLE "ALCOHOLIC BEVERAGES," SUBTITLE "COUNTY LIQUOR CONTROL BOARDS AND DISPENSARIES," BE AND IT IS HEREBY REPEALED AND RE-ENACTED, WITH AMENDMENTS, TO READ AS FOLLOWS:

(H) MEMBERS OF THE SEVERAL BOARDS SHALL RECEIVE COMPENSATION AS FOLLOWS:

(5) SOMERSET COUNTY—ONE THOUSAND DOLLARS (\$1,000.00) PER ANNUM.

SEC. 3. AND BE IT FURTHER ENACTED, THAT SECTION 37(S)(1) OF ARTICLE 87 OF THE SAID CODE (1964 REPLACEMENT VOLUME), TITLE "SHERIFFS," SUBTITLE "COMPENSATION AND DUTIES," BE AND IT IS HEREBY REPEALED AND RE-ENACTED, WITH AMENDMENTS, TO READ AS FOLLOWS:

(S)(1) THE SHERIFF OF SOMERSET COUNTY SHALL RECEIVE AN ANNUAL SALARY OF FOUR THOUSAND TWO HUNDRED DOLLARS (\$4,200.00), AND AN ANNUAL ALLOWANCE OF ONE THOUSAND TWO HUNDRED DOLLARS (\$1,200.00) FOR EXPENSES. HE SHALL APPOINT NOT LESS THAN TWO DEPUTIES, ONE OF WHOM SHALL BE KNOWN AS THE CHIEF DEPUTY AND SHALL RECEIVE AN ANNUAL SALARY OF THREE THOUSAND DOLLARS (\$3,000.00), THE SECOND DEPUTY SHALL RECEIVE AN ANNUAL SALARY OF TWO THOUSAND SEVEN HUNDRED DOLLARS (\$2,700.00). THE SHERIFF MAY APPOINT SUCH ADDITIONAL DEPUTIES AS SUCH COMPENSATION AS MAY BE APPROVED BY THE COUNTY COMMISSIONERS. THE SHERIFF OR ONE OF HIS DEPUTIES SHALL ACT AS COUNTY JAILER AND FOR THAT RESPONSIBILITY SHALL RECEIVE ANNUAL COMPENSATION, IN ADDITION TO HIS REGULAR SALARY, IN THE
