five made between the said Richard Snowden the said Joseph Cowman a certain Edm  
Jennings, John Galloway and John Richard They the said Richard Snowden Joseph  
Edmund Jennings, John Galloway and John Richard did enter into several Covenants  
and Causes of Agreement with each other for the Carrying on an Iron Work or Works  
the Business of a Furnace and Forge then and now Erected on the Head and  
Branches of Patuxent River and for which Purposes the said Richard Snowden  
Agree to Convey in Fee Simple Ten Thousand One Hundred Acres of Land in the said  
Articles mentioned and Whereas several other Tracts and Parcels of Land from Thomas  
Linthicum and Edward and Margaret Gaither as well as Haves Horses Waggon  
other Materials and Implem<sup>t</sup>s have been Purchased for the Use and Purpose of  
on the said Works But no Deed or Deeds have been made by the said Richard Snow  
in Pursuance of the said Articles whereby the Estate of the said Lands and Buildings  
thereon still Remain in him Now this Indenture Witnesseth that the said  
Joseph Cowman for and in Consideration of Four Hundred and five Pounds current Money
