

## COUNTY LOCAL LAWS

THE WEST SIDE OF THE RECOMMENDED ZONE 6-C3-4 ON THE NORTHERN THIRD ASSESSMENT DISTRICT COMPREHENSIVE ZONING MAPS; THENCE SOUTHERLY BINDING ALONG THE SAID SIDE OF SAID RECOMMENDED ZONE 450'± TO THE NORTHERN BOUNDARY OF THAT AREA RECOMMENDED FOR 6-C4-5 ON THE RECOMMENDED NORTHERN THIRD ASSESSMENT DISTRICT COMPREHENSIVE ZONING MAPS; THENCE EASTERLY 200'± BINDING ALONG SAID SIDE OF SAID ZONE TO THE WEST SIDE OF CRAIN HIGHWAY (BUS. RT. 3); THENCE NORTHERLY BINDING ALONG SAID SIDE OF SAID ROAD TO THE NORTHERN BOUNDARY OF 6-R22-1 ON THE RECOMMENDED COMPREHENSIVE ZONING MAPS, A DISTANCE OF 100'±; THENCE EAST 150'± BINDING ALONG SAID NORTHERN SIDE OF SAID LATTER-MENTIONED ZONE; THENCE NORTH 150'± BINDING ALONG SAID LATTER-MENTIONED ZONE TO THE SOUTH SIDE OF AQUAHART ROAD; THENCE NORTHERLY ACROSS CRAIN HIGHWAY AND BINDING ON THE EAST BOUNDARY OF THAT PARCEL OF LAND OWNED BY OLIVER M. HODDINOT, RECORDED IN THE LAND RECORDS OF ANNE ARUNDEL COUNTY, MARYLAND, TAX MAP 9, PARCEL 427; A DISTANCE OF 160'± TO THE SOUTH BOUNDARY OF THAT PARCEL OF LAND OWNED BY CARL M. TEPPER AND RECORDED IN THE LAND RECORDS OF ANNE ARUNDEL COUNTY, MARYLAND, LIBER 1176, FOLIO 463; THENCE EASTERLY BINDING ON SAID BOUNDARY OF SAID LATTER-MENTIONED PARCEL AND THE SOUTHERN BOUNDARY OF THAT PARCEL OF LAND OWNED BY ANDREW HOPPER AND RECORDED IN THE LAND RECORDS OF ANNE ARUNDEL COUNTY, MARYLAND, TAX MAP 9, PARCEL 378, FOR A DISTANCE OF 200'± TO THE EASTERN BOUNDARY OF THAT AREA RECOMMENDED FOR 6-C3-4 ON THE RECOMMENDED COMPREHENSIVE ZONING MAPS; THENCE NORTH 90'± TO THE SOUTHERN BOUNDARY OF THAT AREA RECOMMENDED FOR 6-R15-5 BINDING ALONG THE EASTERN BOUNDARY OF THE AREA RECOMMENDED FOR 6-C3-4; THENCE WEST 490'± BINDING ALONG THE SOUTHERN BOUNDARY OF SAID 6-R15-5 TO THE WEST SIDE OF CRAIN HIGHWAY; THENCE NORTH 100± BINDING ALONG SAID WEST SIDE OF SAID ROAD TO ITS INTERSECTION WITH THE NORTH BOUNDARY OF LOT 4, SECTION 6 OF GLEN BURNIE HEIGHTS RECORDED IN THE SUBDIVISION RECORDS OF ANNE ARUNDEL COUNTY, MARYLAND, PLAT BOOK 16, FOLIO 28; THENCE WESTERLY BINDING ALONG SAID LATTER-MENTIONED BOUNDARY OF SAID LOT TO THE SOUTHEAST SIDE OF QUARTERFIELD ROAD, A DISTANCE OF 104.33'±; THENCE SOUTHWEST BINDING ALONG SAID SIDE OF SAID ROAD 17.43'± TO THE PLACE OF BEGINNING.
