D. THE WORD "PERSON" SHALL INCLUDE THE WORDS "INDIVIDUAL", "CORPORATION", "PARTNERSHIP", AND "ASSOCIATION" UNLESS SUCH CONSTRUCTION WOULD BE UNREASONABLE.

E. WHEREVER IN THIS ORDINANCE THE MASCULINE GENDER IS USED, SUCH WORDS SHALL BE CONSTRUED TO INCLUDE THE FEMININE GENDER.

F. THE WORD "AGENCY" WHEN USED TO DESIGNATE A SUBORDINATE ELEMENT OF GOVERNMENT SHALL BE CONSTRUED AS INCLUDING ALL OFFICES, DEPARTMENTS, INSTITUTIONS, BOARDS, COMMISSIONS, AND CORPORATIONS OF THE COUNTY GOVERNMENT AND, WHEN SO SPECIFIED ALL OFFICES, DEPARTMENTS, INSTITUTIONS, BOARDS, COMMISSIONS, AND CORPORATIONS WHICH RECEIVE OR DISBURSE COUNTY FUNDS.

G. "EMPLOYEE" MEANS AN INDIVIDUAL APPOINTED TO ANY POSITION WITH THE COUNTY COUNCIL, THE EXECUTIVE BRANCH, AND ZONING HEARING EXAMINER.

H. "BUSINESS DEALINGS WITH THE COUNTY" SHALL MEAN ANY CONTRACT, WORK OR BUSINESS, OR THE PERFORMANCE OF, OR LITIGATION ARISING OUT OF OR INVOLVING ANY SUCH CONTRACT, WORK OR BUSINESS OR THE SALE OR ACQUISITION OF ANY PROPERTY, THE EXPENSE, PRICE OR CONSIDERATION FOR WHICH IS PAYABLE TO OR FROM THE COUNTY TREASURY OR BY ANY ASSESSMENT LEVIED PURSUANT TO LAW; OR THE PURCHASE, LEASE, RENTAL, OR LETTING OF, OF GRANT OR LICENSE OR PERMIT IN RELATION TO, ANY REAL OR OTHER PROPERTY BELONGING TO OR TAKEN BY THE COUNTY, OR WHICH SHALL BE SOLD FOR TAXES OR ASSESSMENTS, OR BY VIRTUE OF LEGAL PROCESSES OR ANY PROVISIONS OF LAW BY OR AT THE SUIT OF THE COUNTY; OR OBTAINING OF ANY LICENSE FROM THE COUNTY FOR ZONING, OR APPLICATION INVOLVING ANY ZONING PROVISIONS.

I. "CONTRACT" MEANS ANY CLAIM, ACCOUNT, OR DEMAND AGAINST OR AGREEMENT WITH THE COUNTY, EXPRESS OR IMPLIED.

J. "FINANCIAL INTEREST" MEANS OWNERSHIP BY THE OFFICIAL OR HIS SPOUSE, JOINTLY OR SEVERALLY, OF A TOTAL OF MORE THAN THREE (3%) PER CENTUM OF THE INVESTED CAPITAL OR CAPITAL STOCK OF OR RECEIPT OF A TOTAL COMBINED COMPENSATION OF MORE THAN
