

COUNTY LOCAL LAWS

COMBINATION OF EDUCATION AND EXPERIENCE.

(285A) SECRETARY, EXECUTIVE—ELDER AFFAIRS. GRADUATION FROM A COLLEGE OR UNIVERSITY OF RECOGNIZED STANDING; PREFERABLY WITH FIVE (5) YEARS OF EXPERIENCE IN BUSINESS OR PUBLIC MANAGEMENT; OR ANY EQUIVALENT COMBINATION OF EDUCATION AND EXPERIENCE.

(350A) TECHNICIAN, MOSQUITO CONTROL. GRADUATION FROM HIGH SCHOOL AND TWO (2) YEARS OF COLLEGE TRAINING IN THE AREA OF ENTOMOLOGY OR BIOLOGY; PREFERABLY WITH ONE (1) YEAR OF EXPERIENCE IN A LARVICIDING PROGRAM; OR ANY EQUIVALENT COMBINATION OF EDUCATION AND EXPERIENCE.

SECTION 3. AND BE IT FURTHER ENACTED, That Sections 1-217 (62), (73), (148), (149) and (188) of said Code, Title, Subtitle and Article, be and they are hereby repealed, and new Sections 1-217 (62), (73), (148), (149) and (188) be, and they are hereby enacted in lieu thereof, to stand in the place of the sections so repealed, and to read as follows:

Section 1-217

(62) CAPTAIN, FIRE. COMPLETION OF TWO (2) YEARS OF ACCEPTABLE COLLEGE TRAINING AND FOUR (4) YEARS OF PROGRESSIVELY RESPONSIBLE SERVICE IN THE ANNE ARUNDEL COUNTY FIRE DEPARTMENT; ONE (1) YEAR MUST HAVE BEEN AT THE LEVEL OF LIEUTENANT OR HIGH SCHOOL AND SIX (6) YEARS OF PROGRESSIVELY RESPONSIBLE EXPERIENCE; ONE (1) YEAR OF EXPERIENCE MUST BE AT THE LEVEL OF LIEUTENANT; OR ANY EQUIVALENT COMBINATION OF EDUCATION AND EXPERIENCE.

(73) CHIEF, FIRE DIVISION. COMPLETION OF TWO (2) YEARS OF ACCEPTABLE TRAINING AND SIX (6) YEARS OF PROGRESSIVELY RESPONSIBLE SERVICE IN THE ANNE ARUNDEL COUNTY FIRE DEPARTMENT; TWO (2) YEARS OF WHICH MUST HAVE BEEN AT THE LEVEL OF FIRE CAPTAIN OR HIGH SCHOOL AND SEVEN (7) YEARS OF EXPERIENCE, TWO (2) OF WHICH MUST HAVE BEEN AT THE LEVEL OF CAPTAIN; OR ANY EQUIVALENT COMBINATION OF EDUCATION AND EXPERIENCE.

(148) FIREFIGHTER II. GRADUATION FROM A RECOGNIZED HIGH SCHOOL AND ONE (1) YEAR OF EXPERIENCE IN THE ANNE ARUNDEL COUNTY FIRE DEPARTMENT; OR ANY EQUIVALENT COMBINATION OF EDUCATION AND EXPERIENCE.

(149) FIREFIGHTER III. GRADUATION FROM A RECOGNIZED HIGH SCHOOL AND TWO (2) YEARS OF EXPERIENCE IN THE ANNE ARUNDEL COUNTY FIRE DEPARTMENT; AND ANY EQUIVALENT COMBINATION OF EDUCATION AND EXPERIENCE.

(188) LIEUTENANT, FIRE. COMPLETION OF TWO (2)
