

## MONTGOMERY COUNTY

MARYLAND-NATIONAL CAPITAL PARK AND PLANNING COMMISSION AND THE WASHINGTON SUBURBAN SANITARY COMMISSION TO DETERMINE THE INTERRELATIONSHIP BETWEEN EXISTING AND PROPOSED HEALTH PROGRAMS, SERVICES AND FACILITIES AND PRESENT AND PLANNED LAND USE, TRANSPORTATION, WATER AND SEWER AND OTHER PUBLIC FACILITIES AND GOVERNMENTAL PROGRAMS. RECOMMENDATIONS WILL BE SOUGHT FROM THE MARYLAND-NATIONAL CAPITAL PARK AND PLANNING COMMISSION CONCERNING CONSISTENCY OF FACILITIES WITH ADOPTED GENERAL, MASTER AND FUNCTIONAL PLANS.

(7) RECOMMEND TO THE COUNTY COUNCIL FOR ADOPTION AND PUBLICATION BY THE COUNCIL, SITTING AS THE COUNTY BOARD OF HEALTH, SUCH RULES AND REGULATIONS AS ARE DEEMED NECESSARY TO IMPLEMENT THE PROVISIONS OF THIS SUB-CHAPTER. PRIOR TO FORWARDING SUCH RECOMMENDATIONS TO THE COUNCIL, THE BOARD SHALL SEEK COMMENTS THEREON, IF ANY, FROM THE COUNTY EXECUTIVE.

(B) IN ADDITION TO ANY OTHER DUTY OR RESPONSIBILITY PROVIDED IN THIS SUB-CHAPTER, THE BOARD SHALL HAVE THE FOLLOWING DUTIES AND RESPONSIBILITIES:

(1) ADVISE THE COUNTY HEALTH OFFICER, THE COUNTY EXECUTIVE AND THE COUNTY COUNCIL ON GOALS, PRIORITIES, FACILITIES, PROGRAMS, LEVELS OF FUNDING AND EFFECTIVENESS OF PUBLIC HEALTH, MENTAL HEALTH, AND ENVIRONMENTAL HEALTH EFFORTS AND RELATED ACTIVITIES WITHIN MONTGOMERY COUNTY.

(2) ADVISE THE HEALTH OFFICER, THE EXECUTIVE AND THE COUNCIL ON THE FEASIBILITY, PLANNING AND ADEQUACY OF PRIVATE HEALTH, MENTAL HEALTH AND ENVIRONMENTAL HEALTH FACILITIES, PROGRAMS AND ACTIVITIES WHICH REQUIRE COUNTY GOVERNMENT APPROVAL AND/OR FUNDING.

(3) ASSIST IN DEVELOPING AND MAINTAINING COOPERATIVE RELATIONSHIPS BETWEEN PUBLIC AND PRIVATE AGENCIES IN MATTERS AFFECTING HEALTH PROGRAMS AND SERVICES.

24-29 STAFF DIRECTOR, APPOINTMENT; STAFF PERSONNEL; BUDGET PREPARATION.

AN INDIVIDUAL WITH PROFESSIONAL COMPETENCE IN THE FIELD OF HEALTH PLANNING SHALL BE APPOINTED BY THE COUNTY EXECUTIVE, SUBJECT TO CONFIRMATION BY THE COUNTY COUNCIL, TO SERVE AS THE STAFF DIRECTOR OF THE MONTGOMERY COUNTY HEALTH PLANNING ADVISORY BOARD. WHEN MAKING THIS APPOINTMENT, THE EXECUTIVE SHALL OBTAIN AND TAKE INTO CONSIDERATION THE ADVICE AND RECOMMENDATIONS OF THE BOARD. SUCH ADDITIONAL PERSONNEL AS THE COUNTY EXECUTIVE SHALL DESIGNATE TO PROVIDE DIRECT STAFF SUPPORT TO THE BOARD SHALL BE UNDER THE IMMEDIATE SUPERVISION OF THE
