Farms & Hereditaments situate Lying and being within the province of Maryland  
in parts beyond the Seas commonly called and known by the names of the Quo-  
rana point or point patience and pennyhill thereto belonging or adjoining,  
Iledmor in Talbot County and Rousbey in the same County and Beverly in Somers-  
set County containing in the whole by Estimation two thousand one hundred  
acres of Land be the same more or Less one moiety or half part of all the said  
Lands Tenements farms and Hereditaments whatsoever with their and Every  
of their appurtenances and of all other my Lands Tenements farms and  
Hereditaments with their and Every of their appurtenances. Also wherewithin  
the said province of Maryland the Remainder and Remainders in reversion &  
reversions thereof and of Every part thereof together with all my Estate right title  
Interest just property claim and demand of me to my said moiety thereof both by  
Law and equity and all deeds evidences and writings Touching or Concerning  
the same I do devise give and bequeath unto my dear and Loving wife Anne  
Rousbey to have and to hold to her and to her heires and assigns for ever I do  
give and bequeath <sup>all my personal Estate whatsoever</sup> ~~all my personal Estate whatsoever~~ <sup>and all my debts</sup> ~~and all my debts~~ My Debts &  
funerall expences discharged to my said dear and Loving wife and of this my  
will I make her my full and sole Executor. In Witness whereof the said  
William Rousbey have hereunto set my hand and seal the day and year above  
written as if Rousby signed sealed published & declared by the said Wm Rousby the  
Testator as if his Last will & Testament in the presence of Constance Hopson
