

TC PROSPECTIVE FRANCHISEES OR SUBFRANCHISORS, OR OTHER PERSONS, TOGETHER WITH A STATEMENT SETTING FORTH THE DATA UPON WHICH THE ESTIMATION OR PROJECTION IS BASED.

(17) A STATEMENT OF ANY COMPENSATION OR OTHER BENEFIT GIVEN OR PROMISED TO A PUBLIC FIGURE ARISING, IN WHOLE OR IN PART, FROM (I) THE USE OF THE PUBLIC FIGURE IN THE NAME OR SYMBOL OF THE FRANCHISE OR (II) THE ENDORSEMENT OR RECOMMENDATION OF THE FRANCHISE BY THE PUBLIC FIGURE IN ADVERTISEMENTS.

(18) A STATEMENT OF THE NUMBER OF FRANCHISES PRESENTLY OPERATING OR PROPOSED TO BE SOLD, AS MAY BE REQUIRED BY RULE OF THE COMMISSIONER.

(19) A STATEMENT AS TO WHETHER FRANCHISEES OR SUBFRANCHISORS RECEIVE AN EXCLUSIVE AREA FRANCHISE OR TERRITORY.

(20) OTHER INFORMATION RELATED TO THE APPLICATION AS THE COMMISSIONER MAY REASONABLY REQUIRE.

(21) OTHER INFORMATION AS THE FRANCHISOR MAY DESIRE TO PRESENT.

(22) WHEN THE PERSON FILING THE APPLICATION FOR REGISTRATION IS A SUBFRANCHISOR, THE APPLICATION SHALL ALSO INCLUDE THE SAME INFORMATION CONCERNING THE SUBFRANCHISOR AS IS REQUIRED FROM THE FRANCHISOR PURSUANT TO THIS SECTION.

APPLICATIONS FOR REGISTRATION, REGISTRATION RENEWAL STATEMENTS, AND AMENDMENTS TO THEM, SHALL BE SIGNED AND VERIFIED BY THE FRANCHISOR OR BY THE SUBFRANCHISOR. THE APPLICANT SHALL PAY A REGISTRATION FEE AS FOLLOWS:

(1) THE FEE FOR FILING AN APPLICATION FOR REGISTRATION OF THE SALE OF FRANCHISES IS \$250.

(2) THE FEE FOR FILING AN APPLICATION FOR RENEWAL OF A REGISTRATION IS \$100.

(3) THE FEE FOR AMENDING A REGISTRATION STATEMENT IS \$50.

IF THE COMMISSIONER FINDS THAT IT IS NECESSARY AND APPROPRIATE FOR THE PROTECTION OF PROSPECTIVE FRANCHISEES OR SUBFRANCHISORS BECAUSE THE APPLICANT HAS FAILED TO DEMONSTRATE THAT ADEQUATE FINANCIAL ARRANGEMENTS HAVE BEEN MADE TO FULFILL THE FRANCHISOR'S OBLIGATIONS TO PROVIDE REAL ESTATE, IMPROVEMENTS, EQUIPMENT, INVENTORY, TRAINING, OR OTHER ITEMS INCLUDED IN THE OFFERING, HE MAY REQUIRE THE ESCROW BY RULE OR REGULATION OR IMPOUND THE FRANCHISEE FEES AND OTHER FUNDS PAID BY THE FRANCHISEE OR
