(III) PAYS A \$25 FEE.

(2) A PERSON MAY NOT DESIGNATE A PARTY AFFILIATION ON A PETITION REQUIRED BY THIS SECTION.

(3) A PERSON SEEKING CANDIDACY SHALL DESIGNATE ON HIS PETITION THE COUNCILMANIC DISTRICT FROM WHICH HE SEEKS ELECTION, OR HE SHALL DESIGNATE THAT HE IS SEEKING ELECTION FROM THE COUNTY AT LARGE. A PERSON SHALL RESIDE IN THE COUNCILMANIC DISTRICT FROM WHICH HE SEEKS ELECTION, AND SHALL BE A REGISTERED VOTER OF SOMERSET COUNTY.

(4) A PERSON EMPLOYED BY OR SUBJECT TO THE AUTHORITY OF THE BOARD OF EDUCATION MAY NOT BE A CANDIDATE FOR ELECTION TO THE BOARD.

(C) ~~(4)~~ A CANDIDATE SHALL DISCLOSE TO THE BOARD OF SUPERVISORS OF ELECTIONS THAT INFORMATION DELINEATED IN ARTICLE 33 CONCERNING CAMPAIGN RECEIPTS AND EXPENDITURES. THE BOARD OF SUPERVISORS OF ELECTIONS SHALL MAKE THE DISCLOSED INFORMATION AVAILABLE TO THE PUBLIC.

~~(2) A CANDIDATE MAY NOT EXPEND MORE THAN \$500 ON HIS CAMPAIGN. IF A CANDIDATE'S EXPENDITURES EXCEED \$500, HE MAY NOT CONTINUE AS A CANDIDATE, AND MAY NOT BE ELECTED TO THE BOARD OF EDUCATION.~~

(D) THE BOARD OF SUPERVISORS OF ELECTIONS OF SOMERSET COUNTY SHALL ESTABLISH PROCEDURES FOR THE ELECTION OF THE BOARD OF EDUCATION. THE BOARD OF SUPERVISORS OF ELECTIONS SHALL PLACE THE NAMES OF ALL CANDIDATES ON THE BALLOT WITH NO DESIGNATION OF PARTY AFFILIATION IN A MANNER TO ALLOW A NONPARTISAN ELECTION. THE BOARD OF SUPERVISORS OF ELECTIONS SHALL ESTABLISH PROCEDURES FOR A PRIMARY ELECTION IF REQUIRED. THE BOARD SHALL SCHEDULE THE PRIMARY AT THE SAME TIME AS THE PRIMARY ELECTION FOR OTHER ELECTED OFFICES.

(E) IF MORE THAN TWO CANDIDATES FILE FOR A PARTICULAR SEAT ON THE BOARD OF EDUCATION, THE BOARD OF SUPERVISORS OF ELECTIONS SHALL HOLD A PRIMARY ELECTION. ONLY THOSE TWO PERSONS WHO RECEIVE THE GREATEST NUMBER OF VOTES FOR A PARTICULAR SEAT SHALL BE PLACED ON THE BALLOT FOR THE GENERAL ELECTION.

~~(F)~~ (F) THE CANDIDATE FROM EACH OF THE FOUR COUNCILMANIC DISTRICTS WHO RECEIVES THE GREATEST NUMBER OF VOTES IS DECLARED ELECTED TO THE BOARD FROM THAT COUNCILMANIC DISTRICT. THE CANDIDATE WHO RECEIVES THE GREATEST NUMBER OF VOTES OF ANY CANDIDATE SEEKING ELECTION AT LARGE IS DECLARED ELECTED TO THE BOARD.
