

AND EACH ANNUAL RENEWAL, SHALL SHOW THE INACTIVE LICENSE NUMBER, IF ANY, AND THE NAME, HOME ADDRESS, OFFICE ADDRESS, AND TELEPHONE NUMBER, DENTAL DEGREE, SCHOOL OF GRADUATION, AND YEAR OF GRADUATION OF THE APPLICANT, AND STATE WHETHER OR NOT HE IS ENGAGED IN THE REGULAR PRACTICE OF DENTISTRY OUTSIDE OF THIS STATE.

(C) THE HOLDER OF AN INACTIVE LICENSE MAY NOT PRACTICE DENTISTRY IN THIS STATE.

(D) IN ORDER FOR A HOLDER OF AN INACTIVE LICENSE TO RESUME THE PRACTICE OF DENTISTRY IN THIS STATE, HE SHALL OBTAIN FROM THE BOARD A LICENSE IN ACCORDANCE WITH THE PROVISIONS OF SECTIONS 1, 4, AND 5 OF THIS ARTICLE. THE BOARD SHALL WAIVE THE EXAMINATION REQUIREMENT IF THE APPLICANT HAS REGULARLY PRACTICED DENTISTRY IN ANOTHER STATE WITHIN THE 3-YEAR PERIOD IMMEDIATELY PRECEDING THE FILING OF HIS APPLICATION. REVOCATION OR SUSPENSION OF A LICENSE TO PRACTICE DENTISTRY IN ANOTHER STATE IS A SUFFICIENT GROUND FOR DENIAL OF A LICENSE TO RESUME THE PRACTICE OF DENTISTRY IN THIS STATE.

(A) THE BOARD MAY NOT ISSUE THE ANNUAL CERTIFICATE OF REGISTRATION PROVIDED FOR IN SECTION 29(D) OF THIS ARTICLE, TO A DENTAL HYGIENIST NOW LICENSED BY THE STATE OF MARYLAND, BUT NOT REGULARLY PRACTICING DENTAL HYGIENE IN THIS STATE FOR A PERIOD OF 3 YEARS IMMEDIATELY PRECEDING THE DATE OF THE ANNUAL REGISTRATION THEN REQUIRED.

(B) THE BOARD SHALL ISSUE TO DENTAL HYGIENISTS NOW LICENSED BY THE STATE OF MARYLAND, BUT NOT ENTITLED TO THE ANNUAL CERTIFICATE OF REGISTRATION UNDER SUBSECTION (A), ON HIS OR HER APPLICATION, AN INACTIVE LICENSE, RENEWABLE ANNUALLY BEFORE APRIL 1 OF EACH YEAR, FOR AS MANY YEARS AS THE HYGIENIST DESIRES TO RENEW THE INACTIVE LICENSE, AND SUBJECT TO PAYMENT OF A REASONABLE LICENSE OR ANNUAL RENEWAL FEE SET BY THE BOARD. THE APPLICATION FOR AN INACTIVE LICENSE, AND EACH ANNUAL RENEWAL, SHALL SHOW THE INACTIVE LICENSE NUMBER, IF ANY, AND THE NAME, HOME ADDRESS, OFFICE ADDRESS, AND TELEPHONE NUMBER, DEGREE, SCHOOL OF GRADUATION, AND YEAR OF GRADUATION OF THE APPLICANT, AND STATE WHETHER OR NOT HE OR SHE IS ENGAGED IN THE REGULAR PRACTICE OF DENTAL HYGIENE OUTSIDE OF THIS STATE.

(C) THE HOLDER OF AN INACTIVE LICENSE MAY NOT PRACTICE DENTAL HYGIENE IN THIS STATE.

(D) IN ORDER FOR A HOLDER OF AN INACTIVE LICENSE TO RESUME THE PRACTICE OF DENTAL HYGIENE IN THIS STATE, HE OR SHE SHALL OBTAIN FROM THE BOARD A LICENSE IN ACCORDANCE WITH THE PROVISIONS OF SECTIONS 27, 28, AND 29 OF THIS ARTICLE. THE BOARD SHALL WAIVE THE EXAMINATION REQUIREMENT IF THE APPLICANT HAS REGULARLY PRACTICED DENTAL HYGIENE IN ANOTHER STATE WITHIN THE 3-YEAR PERIOD IMMEDIATELY PRECEDING THE FILING OF HIS OR HER APPLICATION. REVOCATION OR SUSPENSION OF A LICENSE TO PRACTICE DENTAL HYGIENE IN ANOTHER STATE IS
