

TRANSFER WITHIN 30 DAYS, THE REQUEST AUTOMATICALLY IS APPROVED AS REQUESTED; AND

(II) EXCEPT IN BALTIMORE CITY, WHERE THE PROVISIONS OF THE CITY CHARTER GOVERN, TRANSFERS OF APPROPRIATIONS WITHIN A MAJOR FUNCTION MAY BE MADE AT THE DIRECTION OF THE BOARD OF TRUSTEES AND THE COUNTY GOVERNING BODY SHALL BE NOTIFIED WITHIN 30 DAYS OF THE TRANSFER.

(D) BORROWING.

EACH COUNTY GOVERNING BODY MAY BORROW MONEY TO PURCHASE LAND AND CONSTRUCT CAPITAL IMPROVEMENTS FOR A COMMUNITY COLLEGE. MONEY MAY BE BORROWED ON TERMS AND CONDITIONS THE COUNTY GOVERNING BODY CONSIDERS PROPER, SUBJECT TO ANY REQUIREMENTS OF LOCAL LAW APPLICABLE TO THE CREATION OF PUBLIC DEBT.

REVISOR'S NOTE: This section is new language derived without substantive change from Art. 77A, §6, except for the last two sentences.

"County governing body" is substituted for the present references to "the local governing body" to conform with the terminology used in other revised articles.

In subsection (c)(1) of this section, reference to any "major" function is added to conform with the language of the second and fourth sentences of present Art. 77A, §6; now subsections (b) and (c)(2) of this section. This is correct, since the prohibition on over spending applies only to "appropriated" funds, and since funds are appropriated only to "major" functions.

The last two sentences of present Art. 77A, §6, which relate to borrowing for regional community colleges now appear in §16-303 of this title.

16-403. STATE, COUNTY, AND STUDENT SUPPORT OF COMMUNITY COLLEGE CURRENT EXPENSES.

(A) DEFINITIONS.

(1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.

(2) "COUNTY SHARE" MEANS THE MINIMUM AMOUNT OF MONEY TO BE PROVIDED EACH YEAR TO A COMMUNITY COLLEGE BY THE COUNTY THAT SUPPORTS THE COMMUNITY COLLEGE OR, IN THE CASE OF A REGIONAL COMMUNITY COLLEGE, THE TOTAL AMOUNT OF MONEY TO BE PROVIDED EACH YEAR TO THE REGIONAL COMMUNITY COLLEGE BY ALL COUNTIES THAT SUPPORT THE REGIONAL COMMUNITY COLLEGE.

(3) "POPULATION" MEANS POPULATION AS DETERMINED BY THE 1970 CENSUS.
