

COUNTY LOCAL LAWS

Bill No. 966, 2004 Legislative Session

A BILL TO AMEND § 11-5 F, "BEER, WINE AND LIQUOR LICENSES," TALBOT COUNTY CODE, TO PERMIT THE TALBOT COUNTY BOARD OF LIQUOR LICENSE COMMISSIONERS TO ISSUE A CLASS B-F (BANQUET FACILITY) BEER, LIGHT WINE AND LIQUOR (ON-SALE) LICENSE FOR A BANQUET FACILITY; TO AMEND § 11-6 A.(1) AND (2), "ENDORSEMENTS," TALBOT COUNTY CODE, TO PROVIDE THAT A CATERER'S ENDORSEMENT MAY BE ISSUED TO THE HOLDER OF A B-F (BANQUET FACILITY) LICENSE; AND TO ESTABLISH A LICENSE FEE OF \$1,200 AND AN APPLICATION FEE OF \$100 FOR THE B-F LICENSE.

Bill No. 967 As Amended, 2004 Legislative Session

A BILL TO FIX, IMPOSE, AND PROVIDE FOR THE COLLECTION OF DEVELOPMENT IMPACT FEES FOR FINANCING IN WHOLE OR IN PART, THE CAPITAL COSTS OF ADDITIONAL OR EXPANDED PUBLIC WORKS, IMPROVEMENTS, AND FACILITIES, INCLUDING BRIDGES, STREETS AND ROADS, PARKS AND RECREATIONAL FACILITIES, AND SCHOOLS REQUIRED TO ACCOMMODATE NEW CONSTRUCTION OR DEVELOPMENT.

Bill No. 969, 2004 Legislative Session

A BILL TO AMEND THE TALBOT COUNTY CODE, CHAPTER 190 ZONING, ARTICLE IV LAND USE REGULATIONS BY ZONING DISTRICTS, SECTION 190-19 GENERAL TABLE OF LAND USE REGULATIONS TO EXEMPT WHOLESALE GREENHOUSE STRUCTURES FROM SITE PLAN REVIEW.

WICOMICO COUNTY

Bill No. 2004-2

AN ACT to amend Chapter 225 of the Wicomico County Code, entitled "Zoning", Section 225-82, entitled "General off-street parking requirements," by the addition of paragraph K permitting the use of alternative paving or surface treatments for driveways and parking areas by special exception.

Bill No. 2004-3

AN ACT to amend Chapter 138 of the Wicomico County Code, entitled "Electrical Standards", Section 138-21, entitled "Examinations," paragraph B, entitled "Electrician General," to reduce the examination passing grade to 70 Percent.
