

(2) After deducting all costs incurred in administering this title on a pro rata basis, the balance of funds shall be distributed at least once annually or at any other time that the administrator determines. The funds shall be allocated as follows:

(i) [To] AFTER-AN-ANNUAL-DEDUCTION-OF-\$500,000 FOR-PAYMENT-TO-THE-MARYLAND-LEGAL-SERVICES-CORPORATION-TO-SUPPORT THE-ACTIVITIES-OF-THE-CORPORATION, TO each county of the State, the funds of owners whose last known address was shown by the records of the holder to be in the county; and

(ii) [To] AFTER-AN-ANNUAL-DEDUCTION-OF-\$500,000 AFTER A DEDUCTION OF UP TO \$500,000 ANNUALLY FOR PAYMENT TO THE MARYLAND LEGAL SERVICES CORPORATION TO SUPPORT THE ACTIVITIES OF THE CORPORATION, TO the State for deposit in the general funds of the State, the funds of owners for whom there is no last known address in the State.
