

REGISTER FOR AND PAY A SINGLE FEE OF \$100 ON BEHALF OF ALL ITS MEMBERS, OFFICERS, AGENTS, AND EMPLOYEES. HOWEVER, THE NAMES AND ADDRESSES OF ALL OFFICERS, AGENTS, AND EMPLOYEES OF THE PROFESSIONAL FUND-RAISING COUNSEL AND ALL OTHER PERSONS EMPLOYED TO WORK UNDER ITS DIRECTION MUST BE LISTED IN THE APPLICATION.

(B) EACH REGISTRATION IS VALID FOR 1 YEAR AND MAY BE RENEWED FOR ADDITIONAL 1-YEAR PERIODS UPON APPLICATION TO THE SECRETARY OF STATE AND PAYMENT OF THE \$100 RENEWAL FEE.

(C) (1) IF THE SECRETARY OF STATE FINDS THAT THE REGISTRANT HAS COMPLIED WITH THE REQUIREMENTS OF THIS SUBTITLE AND THE RULES AND REGULATIONS ADOPTED PURSUANT TO IT, THE REGISTRATION SHALL BE APPROVED.

(2) IF THE REGISTRATION IS NOT APPROVED OR DENIED WITHIN 30 DAYS OF ITS RECEIPT, THE REGISTRATION SHALL BE DEEMED APPROVED.

(3) (I) AN APPLICANT WHOSE APPLICATION FOR REGISTRATION IS DENIED MAY, WITHIN 30 DAYS FROM THE DATE OF NOTIFICATION OF THE DENIAL, REQUEST IN WRITING A HEARING BEFORE THE SECRETARY OF STATE.

(II) A HEARING SHALL BE HELD WITHIN 60 DAYS FROM THE DATE THE SECRETARY OF STATE RECEIVES THE REQUEST.

(D) PROFESSIONAL FUND-RAISING COUNSEL SHALL FILE WITH THE SECRETARY OF STATE A COPY OF ANY AGREEMENT ENTERED INTO WITH A CHARITABLE ORGANIZATION WITHIN 10 DAYS OF ITS EXECUTION. A PERSON MAY NOT LAWFULLY ACT AS A PROFESSIONAL FUND-RAISING COUNSEL FOR A CHARITABLE ORGANIZATION UNLESS AN AGREEMENT IS EXECUTED CONTAINING:

- (1) THE SERVICES TO BE PROVIDED;
- (2) THE NUMBER OF PERSONS TO BE INVOLVED IN PROVIDING THE SERVICES;
- (3) THE TIME PERIOD OVER WHICH THE SERVICES ARE TO BE PROVIDED; AND
- (4) THE METHOD AND FORMULA FOR COMPENSATION FOR THE SERVICES.

(E) PROFESSIONAL FUND-RAISING COUNSEL SHALL NOT RECEIVE COMPENSATION FROM A CHARITABLE ORGANIZATION IF THE CONSIDERATION OR PECUNIARY BENEFIT DEPENDS IN WHOLE OR PART UPON THE NUMBER OR VALUE OF CONTRIBUTIONS MADE AS A RESULT OF THE EFFORTS OF THE PROFESSIONAL FUND-RAISING COUNSEL.
